Harriet Newman Cohen, known as the "doyenne" of matrimonial and family law attorneys in New York City, is a founding partner of Cohen Stine Kapoor LLP, a dynamic post-pandemic matrimonial and family law firm that launched on January 1, 2021. She has partnered with Martha Cohen Stine, her daughter, and Ankit Kapoor, her fellow alumnus, albeit two generations her junior. The new firm's partners span three generations of lawyers.
